

Nominations/Elections for President-Elect

Call for Nominations: Best Publication Award

The Association recognizes the best publications of the year in the field of citizenship education and identity related to children and young people that has been written by CiCea members. The Awards identify and promote excellence in publication in the field and to commend the quality of publication by members of the Association. Publications submitted must be published in the previous year (2011), and must be either authored or co-

authored by a member or members of the Association. Nominations *must be made on the form available at our website (cicea.eu)*, by any member of the Association, including the authors of the nominated work. An anonymised version of the work submitted must be submitted in an electronic copy format. The deadline for nominations for 2011 will open on March 5th and close with all submissions received by April 5th 2012, sent to the

CiCea office (address on the home page) and electronically to cicea@londonmet.ac.uk.

The Executive Committee will nominate a publications award committee, which may contain some or all members of the Executive Committee. The publications award committee will make a shortlist of works, and then announce the winners at the Association's Annual General Assembly (May 2012).

Along with the best Publication Award, CiCea also has its Annual Research Grant and its Outstanding Achievement Award. We look forward to honouring one or more of our members for the work that they have done and to whether or not we will have the financial wherewithal this year to help


Erasmus coordinators' Meeting

The meeting included presentations from Monika Holik, Head of Unit Lifelong Learning; Erasmus and Jean Monet, EACEA, and Project Advisers providing information on operational and financial aspects of project management; and Vanessa Debiais-Sianton

and Endika Bengoetvea, DG EAC, European Commission, who gave updates on the EU's higher education policy and programmes (see <http://eacea.ec.europa.eu>).

At the meeting Peter received a plaque on behalf of CiCe, to recognise the Networks selection for an Erasmus grant. CiCe was one of eight Academic Networks selected from 19 submitted proposals.

Ce numéro de Spirale vise à rassembler des contributions autour de quelques questions transversales aux différentes éducations à :

- Quelles conceptions de l'éducation par relation et/ou par opposition à celle de l'instruction dans le cadre de ces enseignements ? Quels apprentissages sont visés ? Possibles ? Effectifs ? Comment intègrent-ils en particulier la dimension éducative, les valeurs, les « bons comportements » ou les « bonnes pratiques » ? Comment les éventuelles implications éthiques et politiques se concilient-elles avec les fonctionnements scolaires actuels ?

- Quelles conceptions des savoirs dans le cadre de ces éducations, quel statut et quelles fonctions, quelles relations entre les savoirs académiques et les savoirs vernaculaires, quelle place pour les pratiques sociales de référence ? - Quelles sont les pratiques pédagogiques et didactiques spécifiques (si c'est le cas) de telles éducations à ? Existe-t-il des pratiques d'évaluation spécifiques ? Les pratiques pédagogiques dominantes transforment-elles les préconisations et injonctions pour les ramener à des enseignements usuels ? Quelle place et quel rôle sont donnés en particulier aux débats, aux projets, à l'engagement dans l'action au-delà de la classe voire de l'école ? Quelles conditions et quelles formes prennent les éventuels partenariats entre les membres de l'équipe éducative ?

- Si les éducations à, plus que d'autres contenus prescrits, posent comme objectif une transformation de l'agir en société et vis-à-vis de soi, à quelles conceptions des relations société-école renvoient-elles ? S'agit-il d'ancrer l'école dans son environnement social

et de l'enrichir des apports du milieu ? S'agit-il, au contraire, de prendre en charge une éducation qui ne s'élaborerait pas (plus ?) dans la sphère privée ? Quel rôle est alors donné aux familles et plus largement aux partenaires non scolaires ?

Peace Education and teacher training: today in the context of yesterday. A comparative perspective - Finland, Lithuania and Sweden.

Irene Andersson and Roger Johansson (University of Malmoe), Sweden; Arja Virta (University of Turku) and Sirkka Ahonen (University of Helsinki), Finland; Irena Zaleskiene (Vilnius Pedagogical University), Lithuania.

The aim of the project is to compare, analyse and present peace education experiences (political as well as practical), conducted before and after the 1990s by different agencies such as state, civil society and educators in Swedish, Lithuanian and Finnish contexts. The methodology used for gathering data have been analysis of the research literature and political documents and doing so by using content analyses and interviews.

The result of this study

maps out both similarities and differences concerning arenas, actors, policies and changes of concepts used and connected to peace education. Before the 1990s, in the three countries around the Baltic Sea, peace education must be interpreted in the framework of the Cold War. Sweden took a neutral political standpoint, international understanding and disarmament education were seen as peace education advocated by a network of teachers and organizations supported by the political left-wing. In Finland a Peace Education Institute supported by the state and peace organizations worked with international understanding in the light of security politics. Lithuania was a republic in the Soviet Union and as such peace education was a rhetorical tool built on friendship with other nations and celebrating war heroes. After the 1990s the focus is on conflict handling programs in the three countries. But the most major changes have been in Lithuania with a lot of active teachers, new policy documents and peace education as human

rights, democratization and living in peace with others. In Sweden multicultural education seems to be highlighted and the concept peace education is not used any more. In Finland the globalization theme is visible, but the Peace Education Institute is still there. More detailed results are to be found in the grant project report.

The study has shown that it is important to interpret peace education in its contexts, both historically and contemporary. Therefore we would like members of CiCe to collect findings, to write a shorter or a longer contribution on peace education conducted by different agencies; state, civil societies and educators, before and after 1990s, in their own countries with the aim of producing an anthology together.

Learning at university: Challenges, strategies, perspectives for lifelong learning

Vaiva Zuzevičiūtė's recent book, *Learning at university: Challenges, strategies, perspectives for lifelong learning* (2011, Saarbrücken: Lambert Academic publishing, 175 p.: ISBN 9783846515501 (EN) (<https://www.morebooks.de/search/gbl/extendedsearch>)) deals with issues that have to do with a very interesting subject for those of us involved in lifelong learning. Change in the contemporary world is overarching. It is reflected by interaction between increasing requirements for the level of competencies, which is initiated by changes in science and technologies, and the growing number of learning opportunities. This interaction initiates development of a learning society and changes of the dominant paradigms. University, as a part of educational system undergoes a phase of an intensive development due to the fact that a great number of the required competencies could be achieved mainly in the context of higher education. An important factor of lifelong learning is readiness of each student to use learning opportunities that are provided. In analysing lifelong learning the latter issue sometimes lacks the necessary attention. In the interaction of the contexts of expansion of university and the paradigm of lifelong learning the problem - In what way learning of students can be improved and prerequisites for lifelong learning can be created in university studies - of this monograph is analysed. Learning to learn is one of the crucial themes in analysing successful learning throughout the individual's lifetime.

Call for Proposals open until 4th of May 2012!

The HERA (Humanities in the European Research Area) Network is pleased to announce a new Joint Research Programme (JRP) on Cultural Encounters (CE). Nineteen research councils from 18 countries and the European Commis-

sion are making up to €18.5 million available. The research programme will fund new and exciting humanities-centred projects on Cultural Encounters involving researchers from three or more participating countries.

Funding is available for research projects addressing the theme of Cultural Encounters that involve at least three researchers from three different eligible

countries (from the following ones: Austria, Belgium, Croatia, Denmark, Estonia, Finland, Germany, Iceland, Ireland, Lithuania, Luxembourg, Netherlands, Norway, Poland, Portugal, Slovenia, Sweden and United Kingdom).

What is indeed more exciting than creating new course material together with colleagues from different countries? And to have some EU-funding on top of that? ... If a project developer wants EU money, he/she has to play the game by the rules set out by the EU money holder.... and these are nicely written in the guidelines of the programmes. There are many EU educational programmes, but let's concentrate on the best known of all: the Lifelong Learning programme (2009-2013) or the former Socrates programme.

The guidelines for the 2012 call for the Lifelong Learning programme have been published: http://eacea.ec.europa.eu/llp/funding/2012/index_en.php

The deadlines have been moved forward this year: 1/02/2012 for the sub-programmes and 1/03/2012 for the transversal programmes. The Lifelong Learn-

ing Programme (2007 – 2013) supports learning opportunities from junior to senior age in every single life situation through different programmes by sector such as Comenius, Erasmus, Leonardo da Vinci, Grundtvig, Jean Monnet, and transversal key activities, such as Policy Cooperation (including Roma), Languages, ICT, Dissemination and valorisation of results, and also the Jean Monnet programme.

Submitting a project for EU funding...

How to proceed now? You'll be confronted with a choice between mainly: multilateral projects and academic networks. If this is your first go, avoid putting energy in an academic network. This is far too vast for a first time runner: you need a minimum of 25 partners in 25 LLP countries, and then having them all aligned to form a "common platform for sharing knowledge". So go for a multilateral project! A minimum of 3 partners in 3 LLP countries and this for 3 years. Start looking for "kindred spirits", who are also interested in your project! First have a look at the compendia = these are the selected projects. No need to reinvent the wheel! And the EACEA does not like this at all! http://eacea.ec.europa.eu/llp/results_projects/documents/erasmus_compendium_2011_en.pdf
Award criteria – Relevance - Quality of the work programme - Innovative character - Quality of the Consortium - European added value - The cost-benefit ratio – Impact - Quality of the Valorisation plan (= dissemination and exploitation of results) - Participation of organisations from third countries (optional)

Writing? Essential that you follow this file: for e.g. an Erasmus multilateral project.
