# Roger Johansson

## Research interests:

His research has focused on history and subject didactics as well as on modern cultural analysis of social history.

Foci: how we use history to understand ourselves and our world, including the context of school and education. He pays particular attention to interpretation, communication, and formation of history.

“We live not only in space but also in time.”

He has conducted research in the UK, the U.S. and Greenland. His books were published in English, Spanish, Arabic and French, Furthermore, peace history and the use of and ways to use local history have been important fields in his research and publications.

School and education have been a major research interest. He has conducted and co-authored the National evaluation of the history of the 9th grade, written about textbooks in Sweden and the U.S. and heading research circles for scholars and teachers.

He is the director of a Doctoral school in Science and Science Communication and member of the board of the Doctoral school in Subject Didactics.

He wrote about Malmö University's history in 2015 and 2022.

Roger Johansson have also had an interest that has followed through the years for Teacher Education and school where he have, among other things, carried out and co-authored the *National evaluation of history for grade 9*, (together with Professor Lars Berggren) NU03 on behalf of the government/Skolverket. Since 2022, he is project owner and research leader for a research project: *Research on collaboration in teacher education* (ROCIT) at Lund University, funded by the Swedish Research Council with 3.8 million Euro. Including 9 doctoral students doing research on how to build up a cooperation between academia, teacher education and school.







# CTL Journal (Q3)

**Editor-in-chief:** Yusef Waghid, Stellenbosch University, South Africa


**Submission Statistics** Over the past year, the journal considered a total of 41 articles. This number reflects the journal's commitment to expanding the body of knowledge in the field of citizenship education.

**Publication Statistics** Out of the 41 submissions, 21 articles were accepted for publication, resulting in an acceptance rate of approximately 51%. Meanwhile, 15 articles were declined, corresponding to a rejection rate of around 37%.

**Review Process** The average time taken to reach a decision on accepted articles is 175 days

**Geographic Diversity:** Authors hail from various countries, including Indonesia, Kazakhstan, the United States, and Japan. This geographic diversity enriches the journal with a variety of perspectives and contexts.

**Author Profiles:** Authors range from post-graduate students to established academics, indicating that the journal serves as a platform for both emerging and experienced scholars in the field of citizenship education.

## The Civic Journey ~ Our COST proposal process

In order for a COST Action to be submitted, researchers from at least 7 different COST member countries (1 Main Proposer, 6 Secondary Proposers) must come together and propose an Action.

The main aim of the Cost Action is to disseminate the culture, idea, methodology and several different aspects of citizenship in the modern world. It is mainly concentrating on the idea of being and becoming civic individuals that's why we call it a "Civic Journey" to emphasize the transformational nature of the civic power of young people that can inspire sustained engagement in social action, community activism and entrepreneurial spirit.

We know that *supporting better pathways for young people* was the most agreed upon priority for communities across European Union to shape positive change in society. We believe that The Civic Journey project will be a promising response to many challenges and it will enhance understanding of the ways in which young people *are and become* active citizens as they move through life, focusing the places and spaces they develop the knowledges, skills, attitudes, behaviours and experiences, and how local, regional, and national policy can better support them in return.
